 - LWSRA has received a grant for \$10,000 from Aileen S. Andrew Foundation. It will be used for the sensory path and garden as well as the Story path. Staff is working with Grant Seekers to update the letter and list of projects before applying for any more grants.
- b. Foundation Update The first golf outing on August 12 is sold out, and sponsors are still needed. The agency is working on pizza fundraisers. The Board's packets included the 2022-23 Foundation Budget.
